10-line Summary:

Climate Governance • Kaduna State • Fund allocation to forestry

1. Kaduna State faces significant deforestation challenges, impacting biodiversity and climate resilience, making forestry fund allocation critical for sustainable development.
2. Key institutions include the Kaduna State Ministry of Environment, the State House of Assembly, and the Forestry Research Institute of Nigeria, which influence policy and budget decisions.
3. Non-state actors such as local CSOs, environmental NGOs, and private sector stakeholders play a role in advocacy, while international development partners provide funding and technical support.
4. Incentives for forestry funding include potential carbon credit revenues, while constraints involve bureaucratic inefficiencies and competing budget priorities; veto points exist within the legislature.
5. The state budget includes specific allocations for environmental initiatives, with policy hooks in the Kaduna State Climate Change Policy and the National Forestry Policy.
6. Opportunities arise from increased global focus on climate action and potential partnerships with NGOs and private investors for sustainable forestry projects.
7. Risks include pushback from agricultural lobbies prioritizing land for farming over forestry and potential conflicts over land use rights.
8. Information gaps exist regarding the economic value of forests and capacity limitations in local governance structures to effectively manage forestry funds.
9. Likely winners include environmental NGOs and communities benefiting from sustainable practices, while agricultural interests may face losses from reduced land access.
10. Strategic implication: Strengthening governance frameworks for forestry fund allocation can enhance climate resilience and promote sustainable

economic growth in Kaduna State.
